To serve a broad spectrum of program chairs with different privacy needs while maximizing value, we offer two distinct pricing tiers for CLOSET: **Basic** and **Premium**. Each tier is tailored to meet specific needs for program chairs. All prices exclude goods and services taxes.

1. Basic Plan for Research Track

Overview

The Basic Plan is designed for PC chairs who can only release the list of authors and list of PC members for a venue due to privacy constraints. CLOSET returns all possible institutional & co-authorship COIs to get started. This entry-level tier focuses on privacy, core functionalities, and affordability.

Key Results Received By PC Chairs

- Co-authorship-based COI between all authors and PC members
- Institutional COI between all authors and PC members

Input required from PC chairs

- Files containing lists of PC members (reviewers and meta-reviewers)
- A file containing the list of authors
- COI Policy of the venue

2. Premium Plan for Research Track

Overview

The Premium Plan is tailored for PC chairs who require more functionality, information, and analytics related to COI issues associated with the review process at the expense of sharing some private data of the review process with CLOSET.

Key Results Received By PC Chairs

- Co-authorship history between all authors and PC members
- Co-authorship history with assigned reviewers of submissions
- Unreported COIs of authors
- Possible COI violations of submissions with assigned reviewers
- COI between assigned review board members of a submission
- Institutional COI violation and potential violation due to past history
- Potential asymmetric COI (unverified COIs declared by authors per submission) declarations
- Consolidated reports on COI violations and unreported COIs
- CMT ingestion COI file (COI information that can be uploaded to CMT to aid its assignment)
- Bid analysis report (if bidding data is available)
- Diversity report of reviewer assignments

Input required from PC chairs

- Files containing the list of PC members (reviewers, meta-reviewers)
- Files containing author-declared COIs
- Files containing the reviewer assignments of submissions
- Files containing bidding information (if applicable)
- A file containing the list of authors (optional)

- COI policy of the venue

Add-ons (Optional only for Premium Plan)

- Potential submarine COI in assigned reviewers to mitigate bias or collusion and ad-hoc support for submarine COI-related advice during the review process: **USD 1000** for Tier 1 and **USD 2000** for Tiers 2 and 3
- COI management for additional track (e.g., demo, industrial): Same as the cost of the basic plan per track
- Additional post-conference auditing of reviewer assignment: **USD 500** (Tier 1), **USD 1000** (Tier 2), **USD 2500** (Tier 3)
- Diversity features of the review board members: Free
- Recommendation of reviewer assignments to submissions: Free

1. Can I upgrade plans later?

Yes, you can upgrade your plan at any time by paying the remaining amount for a specific plan.

Given input data (involving at most 25 PC members) from the PC chairs as mentioned in the Basic Plan, we offer one-time free results mentioned in the Basic Plan.

3. Is the submarine COI results available for all Premium Plan Clients?

No. The availability of this feature as an add-on is at the discretion of the CLOSET inventor.
